The Applicant(s) shall be responsible for all current consumed upon the premises from date of installation, and shall permit authorized agents of the System free access to the premises of the consumer for the purpose of inspecting, reading, examining, repairing or removing meters or other property, and maintaining right-of-way which includes vegetation management. The Applicant(s) further agrees that in the event they fail to pay a legitimate account, they will pay reasonable attorney's fees incurred by Dickson Electric System for collection of the delinquent account.

The Applicant(s) understand and agree that Dickson Electric System may be limited in the amount of power that it can furnish due to limitations made by the wholesale power supplier. The Applicant(s) further understand and agree that the Dickson Electric System on some occasions may be unable to furnish electric power due to unforeseen and unavoidable circumstances.

The undersigned hereby certifies that they at the present time do not owe Dickson Electric System for prior service and further certifies that this application is their bonafide application and not submitted in conjunction with or on behalf of another person who has had electric service terminated by the System for failure to pay. They further certify that in the event this is a false application, they understand and agree that the electric service may be terminated immediately.
